Respected Sir /Madam

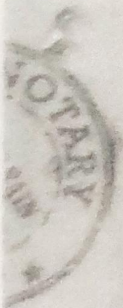
As per your request as well as on the basis of correspondence/ verification, Affiliation is being given to N.R.M. Holy Heart Convent School Budhlada, Distt. Mansa. This Affiliation is being given subject to following conditions :

1. Affiliation sanction is not extendable in any situation and it is should not the concluded that it is mandatory for the supplementary Affiliation from 8th onward class.
2. School should comply Free and Compulsory Education to School Children Rights Act 2009 (Table -I) and Free and Compulsory Education to the Children Rights Rules 2010 (Table -II)
3. School should give 20 percent admission of the total class strength in class first (or in pre school classes which ever is applicable) to those students which belongs to weaker segment and from non facility available groups and provide free and compulsory preliminary education to them, till its completion.
4. Expenses incurred for the education as detailed in para no.3 will be paid to the school as per provisions of Section 12 Sub section (2) of the Act. For the payment, school has to maintain separate bank account.
5. School/Organization will not charge any competition fee and will not adopt any method for the election of children or their parents or its guardian.
6. School will not decline admission to any child due to non availability of birth certificate and will obey the provisions of the Act as prescribed under Section 15.

Physical Examination of mental condition will not be given to any child
a) Children will not be required to pass any "Board Class" till the
completion of the preliminary education.

b) Certificate will be issued to every child under Rule 25, who have
completed the preliminary education.

c) Inclusion of handicapped students / special requirements as per
provisions.

d) It is mandatory for the teachers that they should fulfill minimum
educational qualifications as per Sub Section 24(1). But further
condition is that those teachers who did not fulfill the minimum
educational qualifications at the time of implementation of this act,
they will achieve minimum educational qualifications within 5 years.
Statement of teaching and non teaching staff should be attached.

e) Teachers must fulfill the responsibilities as prescribed under Section
24(b)

f) Teachers should not involve themselves in the tuition work.

5 School should obey the syllabus of the relevant authorities on the
basis of subjects of the school education.

6 School should comply the prescribed conditions and standards as per
Section 19 of the Act. Facilities reported at the time of preceding
verification are as under :

- a) Area of the School Campus
- b) Total area of Building
- c) Area of Playground
- d) Number of Class Rooms
- e) Room for office cum store for Head Teacher
- f) Separate toilets for boys and girls
- g) Facility for Drinking Water
- h) Kitchen to cook lunch
- i) Approach without hurdle
- j) Articles for learning / education / Articles for games / Library.

11 School building or other structure or play ground will be used only
for education and development of skill.

School Societies Registration Act, 1960 (Section 21 of 1960); or is
being run by the trust which as been formed under the Act
implemented from time to time.

13 School is not being run for the benefit of any personal group or group
of persons or for the benefit of any other person.

School will provide the all the information to the District Education Officer as desired by them and school will comply all the instructions give by the competent authority or District Education Officer for the compliance of the conditions of the Affiliation or to remove the shortcomings of the school working.
20. Renewal of the registration of the Institute be ensured, if it is mandatory.
21. After the expiry of the Fire Safety Certificate and Building Safety Certificate it should be obtained again and be sent to this office, if it has not been submitted, the process to cancel the Affiliation of school should be started.
